## SECTION C – CONDITIONS OF APPROVAL

**The following conditions apply to this busking permit:**

1. Busking means a musical or theatrical performance undertaken by a person –
  - a. To entertain the public; and
  - b. Seeking voluntary reward for the performance.
2. Directions of members of the Police or authorised officers of Mackay Regional Council must be complied with at all times;
3. The approval holder must display the approval or produce the approval for inspection on demand by an authorised person;
4. This approval is not transferrable;
5. The approval holder must take specified measures to ensure that the activities authorised by this approval do not cause a nuisance;
6. The approval holder shall not advertise or associate himself/herself with advertising in conjunction with any performance;
7. The direct collection or soliciting of donations is prohibited;
8. The approval holder shall not sell, offer or expose for sale any articles or commodity;
9. The approval holder must not use any form of amplification;
10. The approval holder must operate so that it does not cause undue obstruction to pedestrian or vehicular traffic, for example, by obstructing pedestrian or vehicular access at the entrance to a shop or building;

11. Consent from adjacent property occupants must be obtained for each proposed busking location;
12. From time to time, the approval holder must vary the busking location, for example, no location should be used for more than 3 hours during an 8-hour period;
13. The approval holder must not interfere with the conduct of any activity, including a temporary entertainment event, the subject of an approval of Mackay Regional Council;
14. Busking must not take place within 10meters of any licenced premises;
15. Busking must not be undertaken at a public place during the conduct of an activity which is the subject of an approval of Mackay Regional Council without the written consent of the holder of the approval;
16. Busking may not be performed between the hours of 4:00am and 6:00am.
