1. Executive summary

This Consultation Report has been prepared in accordance with the *Minister's Guidelines and Rules* (MGR) under the Planning Act 2016, to document the process and outcomes of public consultation undertaken on the proposed Planning scheme policy (PSP) amendment 4 - bushfire (proposed PSP amendment).

The proposed Major amendment 2 to the Mackay Region Planning Scheme was also released for public consultation in conjunction with as the proposed PSP amendment. A separate consultation report has been prepared for the proposed Major amendment 2 as it is following a separate amendment process under the MGR.

There were no submissions made on the PSP – bushfire. Some submissions received on the Major amendment 2 also mention the PSP amendment bushfire in the title only, however no submissions mentioned or requested changes to the proposed PSP – bushfire.

This report details when and how consultation was undertaken and lists the submissions received on Major Amendment 2 related to bushfire and justification about how they may relate to the PSP – bushfire. This report also details changes made to the PSP amendment. Changes proposed to the amendment do not significantly change the proposed PSP amendment released for public consultation.

2. Background

The proposed Planning scheme policy amendment – bushfire forms part of a project which is updating all of the PSPs in a series of amendments.

In 2020 Council engaged a consultant to assist in reviewing the planning scheme's bushfire provisions including those within the PSP – bushfire.

The review recommended some amendments to the provisions within the Bushfire hazard overlay code as well as an update the PSP to address matters identified in the review and to comply with the following state guidance materials:

- State Planning Policy state interest guidance material Natural hazards, risk and resilience Bushfire; and
- QFES's Bushfire resilient communities

The changes proposed include:

- A change to the level of assessment making dwelling houses in non-urban areas Accepted development subject to requirements where in the Bushfire hazard overlay;
- Amendments to the Bushfire hazard overlay code to align with the Model code provided by the State Planning Policy - state interest guidance material - Natural hazards, risk and resilience – Bushfire document;
- Removing areas of mapped hazard from the Bushfire hazard overlay map where there is clearly no longer any bushfire hazards within urban areas;
- Amending the PSP bushfire to ensure it supports the amendments to the planning scheme by explaining concepts and terminology and provide further guidance.

The purpose and general effect of the proposed PSP amendment is to:

- support and align with changes made to the planning scheme's bushfire provisions made under Major amendment 2
- explain concepts and terminology related to bushfire requirements in the Mackay region Planning Scheme 2017; and
- update the material to align with latest best practice, and particularly the following state materials:
 - State Planning Policy state interest guidance material Natural hazards, risk and resilience - Bushfire; and
 - QFES's Bushfire resilient communities

3. Purpose of the report

Council is required to prepare a Consultation Report in accordance with the MGR (*Chapter 3, Part 1, Section 3.4* which states that:

At the end of public consultation, the local government must prepare a consultation report about how the local government has dealt with properly made submissions, which is—

- a. provided to each person who made a properly made submission⁸; and
- b. available to view and download on the local government's website; or
- c. available to inspect and purchase in each of the local government's offices.

4. Statutory requirements

The process that council must follow for making a planning scheme policy is prescribed within the MGR.

4.1 Consultation period, materials and actions

Chapter 3, Part 1, Section 3.1 of the MGR requires that council undertake public consultation for a period of at least 20 business days.

Public consultation on the PSP was undertaken in conjunction with consultation on Major Amendment 2 from 7 April 2021 until 21 May 2021 (approximately 31 business days or 6.5 weeks). A copy of the public notice for public consultation is included in Attachment 1 to this report.

Copies of the proposed amendments were made available for inspection in person at council's customer service centres and online at council's website. The following supporting information was also published on council's website to assist in reading and interpreting the proposed PSP amendment:

- the Draft Planning scheme policy bushfire; and
- a factsheet that explained the proposed changes related to bushfire hazards was also prepared and made available on council's website.

Further to the minimum statutory public consultation actions, the following additional consultation actions were also taken:

dedicated webpage on council's website and council's consultation portal Connecting Mackay

- to advise of overlay mapping changes, letters were sent directly to:
 - o property owners affected by a change to the Bushfire hazard overlay mapping
- a submission form template was made available to the public to use on council's website
- a submission lodgement function on council's website
- planning staff were made available during the consultation to answer enquiries via email, phone or at the front counter
- two information sessions, open to the general public and development industry, were held on 29
 April 2021 and 4 May 2021 that covered an overview of:
 - o proposed changes in major amendment 2
 - o proposed changes to bushfire hazard requirements
- planning staff were made available to field phone, email or front counter enquiries during the consultation period and after the consultation period closed.

4.2 Submission registration and consideration process

Council received a total of 13 submissions on Major amendment 2. Two of these were not properly made submissions. The two not properly made submissions were received after the closing date of the consultation period and therefore are not properly made for this reason.

Whilst some of the submissions contained reference to the PSP – bushfire, none of these submissions had any statements or comments that requested changes to the PSP – bushfire. There were a number of submissions that were relevant to the planning scheme's Bushfire hazard overlay code, which is addressed in the Major Amendment 2 Consultation report. Only the submissions that referred to bushfire have been addressed under this consultation report.

All submissions were received by email and once received were registered, acknowledged, and considered. The following table provides an overview of the submission registration and consideration process.

2. Classification of submissions	Submissions were classified by the parts and schedules relevant to the planning scheme. None of the submissions were classified as relevant to the PSP – bushfire.		
Summarising submission matters / grounds	Each submission was read, and the different matters / grounds raised were entered into the Consultation Report per submission. Each submission often covered a range of topics, with some raising similar matters.		
Consideration of matters / grounds of the submissions	Once all matters / grounds were summarised, they were considered and responses to these matters / grounds were prepared.		
5. Consultation report	The Consultation report was prepared which collates steps 3 and 4 above. The consultation report provides a summary of the submissions considered and confirms that the submissions were not related to the PSP - bushfire.

6. Council consideration of submissions	An overview of the submissions received (and advice that none were relevant to the PSP – bushfire) was provided to council, and recommendations on changes to the proposed amendment were made at a Council briefing on 20 October 2021. Via delegated Memo on 11 November 2021, Council formally considered the submissions received during the public consultation period and the recommended changes to the proposed amendment.		
7. Notify submitters of the consideration of submissions	As no submissions were made about the PSP – bushfire, a copy of this submissions report will be made available on Council's website.

4.3 Changes to the proposed amendment

The MGR allows for changes to be made following public consultation where the changes are to:

- a. address issues raised in submissions,
- b. amend a drafting error, or
- c. address new or changed planning circumstances or information.

Any changes to the amendment that are significantly different to the version of the proposed amendment released for public consultation must be consulted on again through the formal consultation process.

Section 6 of this report provides a detailed summary of the changes made to the proposed PSP amendment following public consultation in accordance with the MGR as mentioned above. This section contains:

- detail of the change following public consultation,
- justification as to why the change is not significantly different to the version of proposed amendments released for public consultation,

In summary, the changes proposed to the PSP – bushfire following public consultation are not significantly different to the version of the proposed PSP Amendment 4 - bushfire released for public consultation.
