1.0 Scope

This policy applies to all facilities, services, programs, activities and information owned by or under the control of Mackay Regional Council. It is also applicable to all Council staff (temporary and permanent), Councillors and contractors who are acting on Council's behalf or engaged in Council business.

2.0 Purpose

This policy has been developed to comply with the Federal Disability Discrimination Act 1992 (DDA'92) and the Queensland Anti Discrimination Act 1991. It also:

- Expresses the commitments articulated in Council's Corporate Plan, Mission Statement and corporate objectives of the key strategic priorities of 'Community and Lifestyle' and 'Organisational Excellence and Governance';
- Gives practical recognition to the principle that people with a disability have the same fundamental human rights as all other citizens; and
- Minimises Council's exposure to complaints under the DDA '92.

4.0 Definitions

To assist in interpretation the following definitions shall apply:

Disability shall mean refers to any person with a limitation, restriction or disability which has lasted, or is likely to last, for at least six months and restricts everyday activities and includes physical, intellectual, psychiatric and neurological.¹

Discrimination shall mean the practice of treating a person with a disability unfairly because of the disability.

Advocacy shall mean lobbying at Local, State and Federal levels including submitting proposals for legislative change.

Equitable Access shall mean ensuring fair and socially just opportunities to access services, information, programs, facilities, and opportunities to engage in civic life regardless of a person's disability.

Fair and just - the criteria to determine whether an opportunity is fair and just is:

- All reasonable steps have been taken to provide information about the opportunity.
- The person has not been discriminated against.
- It will not cause 'unjustifiable hardship' to the person or the organization providing the access.

5.0 Background

Councils have considerable obligations under the *Commonwealth Discrimination Act* (DDA'92), *The Queensland Anti-Discrimination Act* (1991) and the *Equal Opportunity in Public Employment Act* (1992) to ensure that their facilities, services, programs, activities and information are accessible and provide equitable services to all members of the community.

The 2009 Survey of Disability, Ageing and Carers (SDAC) estimates that 18.5% of Australians have a disability.

Good access is also critical for our ageing population as demographic forecasting indicates that by 2031 almost 18% of MRC's total population base will be aged 65 years or older. This percentage represents over 30,000 persons and is an increase of 7.4% over 2006 figures.

Access issues also affect the relatives, friends and supporters of people with a disability and aged people as well as many others eg parents with prams and pushchairs. It may therefore be concluded that residents with access limitations make up a significant percentage of the population of the Mackay Regional Council region.

Equitable Access Policy

Mackay Regional Council's Disability Discrimination Act (DDA) Action Plan has been developed to support this policy and stated outcomes and to provide clear strategies and actions to achieve the objectives.

6.0 Policy Statement

Mackay Regional Council acknowledges that equitable access reinforces the rights of people with a disability and maximizes civic participation. Council commits to demonstrating best practice by identifying and removing barriers that prevent people from knowing about, using and/or participating in its services, facilities, programs, activities, information, open spaces or decision making processes.

Mackay Regional Council will achieve the following outcomes:

- Where possible provide equitable access to Council provided services, facilities, programs, activities, information, buildings and open spaces for all residents and visitors;
- Improved advocacy with regard to equitable access to services, facilities, programs, information, activities, buildings and open spaces for all residents and visitors, that are provided or managed by the private and community sectors or by other levels of government;
- Improved decision-making through engagement of people with disabilities in community consultation and public participation;
- Increased utilisation of services, programs, activities, facilities, information and open spaces by people with disabilities;
- Greater participation by people with disability in community and public life;
- A more inclusive community;
- Proactive planning for equitable access for people with a disability and an ageing population in the built environment.

The objectives of the policy are to:

- Guide and improve Council's planning, design and implementation processes to incorporate best practice access and equity principles in the provision of facilities, services, programs, information and open spaces and in conducting Council's activities;
- Strengthen Council's ability to pursue equitable access through lobbying other providers of facilities, services, programs, activities, information and open spaces at local, State and Commonwealth levels;
- Raise awareness of the equitable access and discrimination issues that exist for residents and visitors to the Mackay Regional Council area;
- Increase representation in Council's public participation activities;

- Strengthen Council's ability to pursue equitable access through development assessment;
- Decrease the risk of legal action.

7.0 Review of Policy

This policy will be reviewed when any of the following occur:

- 1. The related documents are amended or replaced.
- 2. Other circumstances as determined from time to time by a resolution of Council

Notwithstanding the above, this policy is to be reviewed at intervals of no more than two years.
