

## SELF ASSESSMENT CHECKLIST FOR SELF-CONTAINED Recreational vehicle grounds - UP to 10 vehicles

This checklist will assist someone who would like to establish a self-contained recreational vehicle ground (RV ground) for up to 10 vehicles and determine whether:

- they comply with all self-assessment requirements; or
- a development application is needed where requirements cannot be met.

Council's Planning Scheme (Mackay Region Planning Scheme 2017) allows for a person to establish, without a development permit, an RV ground in the Rural zone, Tourism zone or Township zone. However, there are self-assessment requirements in the Planning Scheme that need to be met. This checklist does not replace or override these requirements.

The completed checklist will need to be submitted as part of your application for Local Law approval<sup>1</sup>.

Planning Scheme user guide 26 provides guidance and information on how the Planning Scheme applies to establishing RV grounds. There are Local Law requirements and approvals that apply to RV grounds which are outlined in the RV friendly caravan park approvals factsheet.

To check if your proposed RV ground is mapped in a hazard overlay (like bushfire, flooding or erosion prone areas), go to council's MIMAPS<sup>2</sup> mapping site and turn on the relevant overlay mapping under the Mackay Region Planning Scheme section.

## **SECTION 2 – SELF ASSESSMENT CHECKLIST**

To continue completing this self-assessment checklist, your RV ground must:	(YES or NO)
1. Have a maximum of 10 RV sites	
2. Be used for RVs only (Does not include any other types of accommodation or camping)	
3. Be standalone and not form part of an existing tourist park, resort complex or hotel use

4. Provides an area of 75m2 or more for each site
