About 95% of businesses have the potential to generate trade waste.

Many don't know it.

It's up to you, the property owner and/or generator, to protect your environment.

What is trade waste?

Trade waste is the liquid waste produced by any business other than:

- Domestic sewerage
- Illegal substances and
- Storm water



Installing proper trade waste equipment is the property owner or generator's responsibility.



Be prepared

1. Have your trade waste requirements assessed

• Trade waste should be tested through an approved laboratory to ensure emissions meet appropriate requirements. (A list of service providers who will test your trade waste emissions is provided in this pack.)

2. Regularly service your trade waste pre-treatment equipment

 Have your equipment serviced as per manufacturers recommendations. (A list of service providers is provided in this pack.)

Application process

- 1. Apply for approval to discharge trade waste to sewer
- You must apply to Mackay Water for approval. (An application form is available in the pack provided.)
- 2. Install appropriate trade waste pre-treatment equipment and learn to use it properly
- * Call your on-site trade waste pre-treatment service provider to find out how to use your equipment. (A list of all contacts who will show you how to use your equipment is provided in this pack.)

The costs of trade waste

1. Monetary

- Cleaning up sewer contamination is borne by the ratepayer when trade waste is improperly disposed of.
- Your business could be hit with hefty fines and business owners may be charged costs associated with cleaning up illegal discharges and contamination.

2. Environmental

If contaminated water reaches the environment it will contaminate streams, rivers, the earth and kill fish. This is a state and federal offence. Protect the environment for all to enjoy.
